## **9. List of the available research equipment for Dioscuri Centre:**

The library of the Faculty of Law and Administration is part of the University of Warsaw library and information system. The library has an extensive book collection in the area of law, administration and political doctrines, comprised of more than 115,000 volumes of books and journals. Apart from the print sources, the library offers access to electronic legal databases, including Polish (i.e. *Lex*, *Legalis*, *Polska Bibliografia Prawnicza*, *Czytelnia Czasopism Wolters Kluwer*, *Archiwum Dziennika Gazety Prawnej* and *Profinfo*) and global online research services (i.e. *HeinOnline*, *Westlaw* and *Beck-online*). The lecturers and students have also access to non-legal databases within the Virtual Science Library (Polish: *Wirtualna Biblioteka Nauki*) and other research services (e.g. *EBSCO*, *E-book Academic Collection*, *ProQuest Social Science Journal*, *Oxford Journals*, *SpringerLink*).

Users have convenient access to online library catalog (in which the library's acquisitions are recorded) from any computer connected to the Internet and all computer stations available in the library. The library offers 97 workplaces for students and lecturers, including 32 computer stations connected with Internet, equipped with office applications (such as text editors and spreadsheets) and providing access to online databases. In addition, there are 4 computer stations allowing access to the library catalogue, if needed.

### **1) Master of Humanitarian Action**

In 2008 the Faculty of Law and Administration, as the part of the Warsaw University, and the first educational institution from Central Europe, joined NOHA, which is an international association of Universities that aims to enhance professionalism in the humanitarian sector.

Since 2015/2016 academic year, with its Master Programme in Humanitarian Action, Faculty of Law and Administration, along with two other faculties at the Warsaw University, becomes an integral part of the NOHA Joint Master's Programme in International Humanitarian Action.

### **2) Schools of foreign law**

There are 7 schools of foreign law operating at the Faculty of Law and Administration, including but not limited to:

a) **The British Law Centre** – established in 1992 as a joint venture between the University of Cambridge and the University of Warsaw. We teach a 2-year Diploma which covers the core subjects of English law (such as the law of contacts, tort, companies and business, trusts, intellectual property, international trade, elements of EU law and others);

b) **The Center for American Law Studies** – established in 1998 as a joint initiative of the University of Florida Levin College of Law and the Faculty of Law and Administration of the University of Warsaw. As of the beginning of the academic year 2016/17 two law schools from Atlanta, Georgia, have replaced the University of Florida and have formed a consortium with the University of Warsaw to jointly sponsor the Center in its mission to teach Polish law students American Law. We teach a 1-year Diploma;

c) **The School of Law and Economy of China** – the most recent School (launched in 2018), aimed at fostering the specialist knowledge of law, economy and culture of modern day China, through seminars, courses and lectures delivered by leading Chinese academics and practitioners, as well as recognised experts from the United States of America and Europe, with contributions from Polish practitioners who will share their experience in operating on the Chinese market.

### **3) English language courses**

Approximately 60 English language courses are currently provided by our scholars in the form of classes, seminars and lectures.

### **4) Foreign scientists employed at the Faculty of Law and Administration**

Currently there are 3 foreign scientists employed at the Faculty of Law and Administration.
