8. Description of the available laboratory and office space for the Dioscuri Centre (*up to one page in A4 format*):
- The Faculty of Law, Administration and Economics has four modernly equipped buildings with a total usable area of more than 4 000 m<sup>2</sup>. Teaching is conducted in 10 multimedia lecture halls, 28 classrooms, 3 computer labs and a reading room with Internet and databases access. All buildings in the Faculty of Law, Administration and Economics are located in the very center of Wroclaw, near the main University building and Market Square.
- The Dioscuri Center will be located in the building of the Faculty of Law, Administration and Economics, where an office is offered providing excellent working conditions for the research team. The office space will be equipped with computers and office devices (projector, printer, videoconference set-up etc.). The Dioscuri Centre will have free access to seminar and conference rooms (all equipped with computer devices and videoconference set-up), located in all the Faculty premises. Visiting collaborators will be given office space for short-time visitors.
