8. Description of the available laboratory and office space for the Dioscuri Centre

The Faculty possesses 19 000 m² of office space, including the space dedicated exclusively to research groups (currently under renovation) and modern lecturing space (*Collegium Iuridicum Novum*), divided into three buildings in one location in the centre of the city of Poznań. For the Dioscuri Centre the Faculty will make available the rooms located in the building dedicated for research groups: one for the leader and 1-3 for his/her co-workers. The office space will be equipped with computers and office devices (projector, printer, videoconference set-up etc.). The Dioscuri Centre will have free access to seminar and conference rooms (most of them are equipped with computer devices and videoconference set-up), located in all the Faculty premises, as well as to the focus and resting area. Visiting collaborators will be given office space short-time visitors. There is a possibility to invest in extra software and hardware for Dioscuri Centre.

9. List of available research equipment for the Dioscuri Centre :

Library: The Faculty's library is part of the University Library in Poznań, having an extensive collection in various areas of law (including areas of law and forensics) in Polish, English and German. The library offers two ways of access: *in situ* and electronic. For those who prefer working with printed volumes, the Library – apart from the generally available areas – offers workplaces exclusively for the researchers (silent area). The readers may also use the electronic databases (i.a. HeinOnline, SpringerLink, TransLegal) and resources, including e-books and e-journals (of which 130 are of international character). The Library is user-friendly and offers easily available, 24/7 access to its electronic resources from any computer connected to the Internet, including the computer stations at the Library. The Library also offers high quality scanners and scanning services free of charge.

The IT unit: The Faculty offers support of its IT team, as well as a fully equipped computer room for 50 persons, both located in the *Collegium Iuridicum Novum* building. Researchers can make use of a vast pool of computer and electronic hardware for their research and educational goals, such as laptops, cameras,

audio systems. This team might also serve as an IT supporter/collaborator for the Dioscuri Centre.

The Faculty is fully equipped with **e-learning software and devices**.

 - support in job opportunities search for PI's partner(s);

11. Other information about the internationalisation of the research institution, international researchers employed at the institution, the availability of English language seminars etc.

The Faculty is international-oriented with a wide offer for foreign students and researchers.

Annually, the Faculty welcomes around 150-180 international students, in majority, but not limited to, Erasmus+ beneficiaries. The Faculty's lecturers conduct annually more than 30 courses in the English language (both for domestic and international students). We promote *co-tutelle* doctoral studies and, so far, have successfully conducted two joint degree programs (with Ghent University and University of Geneva). We also offer a unique bachelor's degree course - European Legal Studies, run entirely in English by the Faculty's staff and its international collaborators. The curriculum is focused on the legal aspects of the functioning of the European Union.

Two foreign law studies are conducted at the Faculty:

- School of German Law, a venture aimed at getting acquainted with the basis of all branches of German law, addressed to both the academic community as well as people interested in deepening their knowledge, not only about law but also about German culture and intellectual achievements;
- Course in English Law in cooperation with The British Law Centre, that offers a yearly paid course for students, within which fundamental issues in the field of English common law are discussed. A Diploma in English Law and Practice Legal Skills also includes learning legal skills, such as: writing legal letters, making public speeches and drafting contracts.

The Faculty is also host to various international researchers, who conduct short-time or long-time research visits, including lecture deliverers and Fulbright beneficiaries (around 20 visits per year).
